This implies a completion of project work in advance of that date to allow for closeout activities. Further, the start date for the work is dependent upon the selection and award procedures and therefore also unknown. Can you provide guidance on the allowable duration to perform the scope of work described in the RFP.

- Capacity of existing transportation networks to maintain mobility needs.
- Alternative roadway designs or other uses for the right-of-way.

Project will provide planning funding of a pedestrian connection, linking together the Borough of Naugatuck's Metro North Rail Line and downtown core in the west with the Naugatuck River Greenway Trail and State Route Highway 8 in the east. The east and west sides are currently disconnected by the Metro North Rail Line and the Naugatuck River, with affordable and market rate housing developments taking shape on either side of the river.
