Thank you for this information. We can confirm the following:

Billing Account #51471653071, which is listed on your RFP as Andrew Avenue Elementary School, with an address (as listed on the RFP) of 140 Andrew Avenue, Naugatuck, CT, is not eligible for the LREC/ZREC program. This is because there was a contract awarded for this Billing Account number which terminated after 12/12/16 (pursuant to Motions 84/86 in PURA Docket 11-12-06, projects that terminated after 12/12/16 will not be eligible to submit additional Bids/Applications for the LREC/ZREC program). Please note that the site address that pertains to this billing account number in our system is not 140 Andrew Avenue, but rather 164 Andrew Avenue.

Billing Account #51015493091, which is listed on your RFP as Maple Hill Elementary School, with an address (as listed on the RFP) of 641 Maple Hill Road, Naugatuck, CT, is eligible for the LREC/ZREC program. No contracts were awarded to this billing account number, thus, it is eligible for a LREC/ZREC contract."

- 2) Attached are copies of Eversource bills for both Andrew Ave and Maple Hill schools.
- 3) The Borough does not have a prevailing wage requirement, nor does it plan to use any state or federal funds to pay for any work it contracts for not funded under the ZREC program. The Borough relies on the Proposer's expertise as to any prevailing wage restrictions under any funding programs they propose.
- 4) The Borough will review and consider any alternative energy saving proposals the Proposer may make.
