The Naugatuck Police Department is soliciting bids for hardware and software to maintain our existing RSA SecurID® tokens, Licenses and Maintenance Agreements which expire on November 30, 2011. This bid also seeks to increase the total number of tokens that the Naugatuck Police Department currently manages.

DESCRIPTION OF COMMODITY AND/OR SERVICE:

RSA SecurID® software and tokens provides two factor authentication which enhances security to existing databases within a network. RSA SecurID® two-factor authentication is based on something you know (a password or PIN) and something you have (an authenticator)—providing a much more reliable level of user authentication than reusable passwords. It is also the only solution that automatically changes your password every 60 seconds

SCOPE:

The Naugatuck Police Department is soliciting bids for hardware and software to maintain our existing RSA SecurID® tokens, Licenses and Maintenance Agreements which expire on November 30, 2011. This bid also seeks to increase the total number of tokens that the Naugatuck Police Department currently manages.

SYSTEM SPECIFICATIONS:

The bid quotes must include, but not be limited to:

- 1) Replacing the existing sixty (60) RSA SecurID® Tokens which are currently listed as model SID700 and are set to expire on 11/30/11.
- 2) Supply an additional ten (10) RSA SecurID® Tokens making the total of tokens seventy (70) that the Naugatuck Police Department manages.
- 3) Include and outline the costs for any and all maintenance requirements to maintain the RSA SecurID® Tokens and associated software.
- 4) Include and outline the costs for any associated reinstatement fees or other expenditures that the Naugatuck Police Department might incur maintaining the current RSA solution.

SOFTWARE REQUIREMENTS:

- 1) RSA Authentication Manager Base Edition for sixty (60) existing accounts
- 2) RSA Authentication Manager Base Edition for an additional ten (10) new accounts.

HARDWARE REQUIREMENTS:

RSA SecurID® Authenticator's for seventy users. The life span of the Authenticators should be a minimum of thirty-six (36) months.

MAINTENANCE

Maintenance for the RSA SecurID® products for a total of seventy users. (Sixty (60) existing accounts and ten (10) new accounts)

MISCELLANEOUS

Any and all reinstatements fees should be outlined and submitted within the bid sheet.

OPTION

Please submit the cost associated with updating the current software that the Naugatuck Police Department utilizes to maintain its RSA solution and incorporating the new seventy (70) RSA SecurID® Authenticator's into the system. This would include all necessary software patches and other services as deemed necessary.

Bidder will include a minimum of a one-year warranty on all software and hardware components of the installed system.

Bidder will also include an estimate for budgetary purposes on the cost for a second and third-year maintenance contract.
